The third and last petition on this particular topic comes from Vancouver as well. The people who have signed this petition want a public inquiry before the present agreement is negotiated between the two great countries of the United States of America and Canada.

FULL INDEXATION OF FAMILY ALLOWANCE

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, I have another petition signed by people from British Columbia. This petition is with respect to the question of family allowances. The petitioners protest the deindexation of the universal family allowance.

The next petition I have is also from the City of Vancouver. The petitioners protest the deindexation of the family allowance. They say that this will place an extra hard burden on low and middle income households.

The last but not the least petition I have is also on the subject of the deindexation of family allowances. The petitioners protest the fact that this will mean that a very unfair and intolerable burden will be placed upon low and middle income people.
