MINISTER'S POSITION

Mr. Steven W. Langdon (Essex—Windsor): Mr. Speaker, once again this Government is just not being upfront with the Canadian people. I have in front of me the document to which the Minister refers. Why has he attempted to persuade the Canadian people that this outline of liabilities, which is very precise and has nothing to do with the possible lawsuits I have talked about, has any relevance with respect to this question? The points on this document do not deal with this issue.

ACCOUNTABILITY FOR GOVERNMENT FUNDING

MANDATE OF CANADIAN MULTICULTURALISM COUNCIL

confidential report written by the Vice-Chairman of the Canadian Multiculturalism Council and addressed to his Government. It says that all council members are committed supporters of the Conservative Party of Canada, reflect advice from a selection of the Government's principal supporters, and are committed to the Government's survival beyond the next election.

Why has the Minister's Government changed the mandate of this national advisory body and given it over \$350,000 in public funds to safeguard and satisfy the political interests of the Conservative Party of Canada?
