Pacific Railway and the Intercolonial Railway, or any department or officer of the Government of Canada relating to the running privileges given to the Canadian Pacific Railway over the Intercolonial Railway and to the payments to be made therefor; and also; of all agreements for the payments by the Intercolonial Railway to the Canadian Pacific Railway for the cars and engines of the latter run over the Intercolonial Railway.

And also, that they have agreed to the amendments and the consequential amendment made by this House to their amendment to the Bill No. 99, intituled: "An Act respecting the Harbour Commissioners of Montreal," without amendment.
