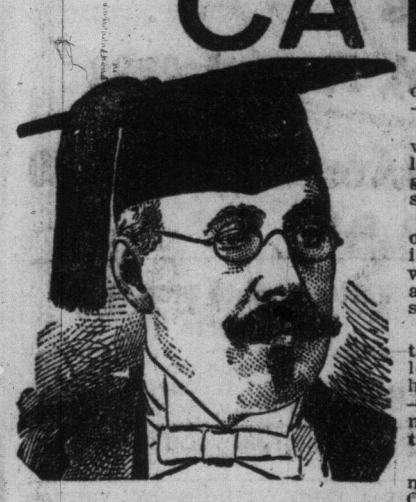

CAN'T GET SALARIES TEACHERS ALL RESIGN

Public School Situation at Sturgeon Falls Reaches an Acute Stage.

STURGEON FALLS, Ont., Dec. 3.—The public schools of Sturgeon Falls are closed to-day and the scholars at their homes for an indefinite vacation, its duration depending upon a solution of the financial problem which has been thrust upon the trustees.

Public school ratepayers are indignant at the state of affairs, which has deprived their children of the instruction for which they have been paying taxes.

Since the plant of the Imperial Paper Mills went into liquidation about two years ago, business has been seriously affected in the town as the plant was the principal and only industry of any size in the community and employed a large number of hands, the mills being practically closed down during the receivership.

On account of a dispute over the amount of taxes due from the mills and the liquidation proceedings, a large sum in public school taxes has been tied up, and the town owes the public school nine thousand dollars on the basis of the 1907-8, besides the year's levy.

Notes were negotiated at the Trades Bank by the trustees to the amount of \$6,000, but a writ was recently issued by the bank against the school to recover this amount, although the amount due from the town for 1907-8 was offered as security.

This week action was taken by the bank to restrain the town from paying over any money to the public school pending their suit, thus shutting off the one possible source of finance to meet the obligations of the board of trustees.

The teachers have only received thirty dollars each since the midsummer vacation and to-day they resented the situation.
