Dec. 23rd. Permission granted to Minas Lodge, No. 67, to meet in Lodge, march in procession to church, and hold Masonic service, then to return to Lodge and have a banquet.

Dec. 30th. Permission granted to Truro Lodge, No. 43, to confer second and third degrees on Bro. E. A. Randall, who was initiated in Temple Lodge No. 47 (new extinct), in Jan. 2nd, 1891, and to re-obligate him in the first degree.

Acacia Lodge, No. 8, forwarded to me in June last, certain proposed bylaws for my approval, I returned them with one of the proposed by-laws approved, but suggested certain alterations to the other to make it more clearly conform to the Constitution. A LIBRARY.

One of our needs is improved library accommodation. The important collection of Masonic books and documents, the property of Grand Lodge is not
