venditioni exponas either in Upper or in Lower Canada, and the Commissioners of Public Works shall thereunder have full power to execute the same, and to sell the said road, real property, rolling stock, plant, goods, chattels and effects, and for 5 those purposes shall possess all the powers vested by law in a Sheriff for enabling him to execute a writ of venditioni exponas; and such Order shall, if a lease of the said road, real property, rolling stock, plant, goods, chattels and effects be thereby ordered, authorize the said Commissioners of Public 10 Works to demise and lease the said road for such term, and upon such regulations and conditions as may be prescribed as aloresaid.

5. It shall be the duty of the Commissioners of Public Works, Commissioners upon entering into possession of the said road, real property, of Public volting stock, plant, goods, chattels and effects under the third account of section of this Act, to cause to be kept an account of the working of receipts, disbursements and transactions of, for and on account Road. of the said Company, and if at the expiration of three months Balance to be from such possession, and upon proceeding to a sale or lease charged to 20 of the said road, real property, rolling stock, plant, goods, Company. chattels and effects, under the fourth section of this Act, any sum of money or balance thereof shall be due to the Company in respect thereof, the same shall be carried to the credit of the said Company on the claim so made by the Order in Council; 25 and if any sum of money, or balance thereof, shall be due to the Province in respect thereof, the same shall be added to the claim so made by the Order in Council, and be equally therewith a lien on the said road, real property, rolling stock, plant, goods, chattels and effects, and be payable out of the proceeds 30 of the sale or demise of the said road, real property, rolling stock, plant, goods, chattels and effects.

6. Whenever a sale or lease of any road, real property, Proceeds of rolling stock, plant, goods, chattels and effects shall take place of sale or lease under this Act, the Commissioners of Public Works shall to payment of stand passessed of the payment o 3b stand possessed of the proceeds thereof, and of any securities debt, and taken therefor as they may receive the same to apply in full balanca, if any, to be depayment or in reduction from time to time (as the case may be) posited in of the claim of the Province against the Company, as ascer- Court. tained as hereinbefore mentioned; and if after full payment of 40 such claim of the Province, any balance or sum of money shall be remaining, the same shall be paid or any securities therefor deposited in the Court of Chancery for Upper Canada or in the Superior Court for Lower Canada, or as such Court shall direct, for payment or appropriation to the said 45 Company or to any creditors thereof in due course of Law.

The vendee or lessee, or his assigns, under any Vendee or Order in Council as hereinbefore mentioned, shall, for the Lessee to have working, management, repair or construction or reconstruction liabilities of of the said road, real property, rolling stock, plant, goods, Company.
