"That in the opinion of this House it is desirable that uniformity should be observed by the various Chartered Banks of the Dominion in sending certified lists of their shareholders to Parliament. To this end it shall be the duty of the Clerk of this House, by circular addressed to the chief officer of such banks, to request that each list of shareholders shall be made up in alphabetical order to the first day of January in every year, and in conformity with the terms of the Statute, 34 Victoria, cap. 5, it shall be duly certified and laid before Parliament within fifteen days after the opening of the Session.
