The Ceremony Witnessed by an Immense and Enthusiastic Crowd.

Civil Marriage in Hungary.

BUDA-PESTH, May 21.—The Lower House of the Hungarian Parliament to-day passed the Civil Marriage Bill for the second time 271 to 105.

British Parliament.

LONDON, May 21.—Parliament resumed its sitting to-day. In the House of Commons Sir Wm. Harcourt announced that the budget clauses would be called up for consideration on Thursday.

Child Murderers.

BUDA-PESTH, May 21.—A boy of 13 years of age and his sister, two years younger, have been arrested in Borku for murdering their father. They killed him while he slept and hid his body in the woods.

Southampton Favored.

LONDON, May 21.—Mr. James Huddart visited Pembroke and Milford Haven on Saturday to examine their claims in connection with the new fast Atlantic service. Plymouth, Swansea, Barrie, Mobile and Galway are also urging their respective claims as ports, though Southampton seems to be the most favored at the present time.

In the Lion's Den.

LONDON, May 21.—The officers of the United States cruiser Chicago have received invitations to visit all the large towns in England. Admiral Erben and Capt. Mahan have accepted invitations to a dinner at the Royal Naval Club on June 2. This club is the most conservative one in London. Nobody under the rank of commander can become a member.

The Princess and Her Camera.

The Princess of Wales has developed a mania for photography. Her camera is her constant companion. She photographed the competitors in the Whitbread sports at Sandringham, frequently takes pictures of her household, and often takes snapshots at chance groups when driving out. She is an expert, as the specimens of her work in most of the rooms of Sandringham House testify.

Execution at Barcelona—Six Victims.

BARCELONA, May 21.—The Anarchists, Codina, Cacerola, Sogas, Bonat, Villabrua and Mir, who were condemned to death for complicity in the attempt of Pallas to assassinate Gen. Martinez de Campos, were put to death at 4 o'clock this morning. The prisoners walked quickly through an underground passage to the plaza of the fortress, where they were to be shot. Upon reaching the place of execution some of them shouted, "Long live Anarchy!" and "Comrades, revenge!" but the others remained silent. The first volley was fatal to all except Sogas and Codina. These two fell to the ground with the others, but were found to be alive, though perhaps mortally wounded. The order was given to shoot them through the head as they lay on the ground, and this was immediately done. Although the execution was public there were few spectators, except the strong force of military ordered to be present as a precaution.

When the firing party was formed, the prisoners were made to kneel and the priests retired. Villabrua shouted: "Murderers, await our revenge!" and Bernat cried "Death to the inquisition!" The platoon fired from a distance of three meters. The convicts had their backs turned toward the troops, and their eyes were bandaged with handkerchiefs. Codina and Villabrua resisted the attempts of the troops to blindfold them, and called upon the onlookers for help. The guards were obliged to use force to compel them to get on their knees. Sogas and Codina were still kneeling after the volley was fired, and were struggling to get upon their feet when they received the second shot, which stretched them beside their companions. The bodies were placed in plain wooden coffins and buried inside the fort.

Manchester's Great Waterway Opened.

MANCHESTER, May 21.—The Queen, accompanied by Prince and Princess Henry of Battenburg and the Princesses of Leiningen, arrived here at 4:30 p.m. It is estimated that 200,000 people lined the route taken by her Majesty in going to and returning from the canal. The entire distance is guarded by troops, volunteers and police. The weather is clear but cold.

MANCHESTER, May 21.—The formal opening of the Manchester Ship Canal to the traffic of the world was accomplished to-day amid the greatest enthusiasm. When the Queen arrived at the station the cheering of the crowds, which occupied every inch of available space was deafening. Her Majesty at once entered one of the royal carriages, which had been sent in advance to this city for the purpose, and was driven to the town hall, where she delivered an address. From the town hall the Queen and her party were driven to the Trafford wharf. A long line of eight miles of streets through which the Queen was driven the greatest enthusiasm prevailed. Hundreds of thousands of people lined the way. Banners, flags, floral arches and Venetian masts were visible everywhere, and the air resounded with cheers.

The Queen was escorted from the station to the town hall and thence to the Trafford wharf by a guard of honor, consisting of field officers of the Fourteenth Hussars. As the procession left the station a troop of yeomanry fell in at the rear and accompanied the royal carriage to Albert Square. Other guards of honor were stationed at the town hall, All Saints' Church, Trafford wharf, Salford and St. George's Church, Chester road and Hulme.

The various guards of honor comprised about 1,000 men, and about 5,000 troops guarded the streets through which the royal procession passed.

Arriving at Trafford wharf, the Queen

embarked on board the royal yacht Enchantress, which at once steamed up the canal in the vicinity of Salford docks, where she formally declared the Manchester Ship Canal open to commerce.

Returning to Trafford wharf, her Majesty re-entered her carriage and was driven to Salford, where she was presented with an address by the mayor and the other authorities of the corporation. The enthusiasm of the people of Salford was manifested quite as marked as that of the people of Manchester. The streets and buildings were magnificently decorated, and the inhabitants turned out en masse to take part in the celebration of the occasion.

After leaving Salford her Majesty was escorted to the station, and at 7:30 o'clock started for Balmoral. During the exercise the Queen conferred the honor of knighthood upon the lord mayor of Manchester, the mayor of Salford, and Joseph Leigh, M.P., son-in-law of David Adamson, chief promoter, and first chairman of the Manchester Ship Canal Company.

Late Canadian News.

Death of the Ex-Manager of the Montreal Bank at Hamilton.

Mr. Jeronimus Rapelje, the oldest inhabitant of St. Thomas, died on Saturday, aged 89 years.

About 500 men in Stratford are affected by the closing down of the G. T. R. locomotive works there.

The Grand Trunk Railway reduced its staff by one-third at the general offices in Toronto on Monday.

During the past week there were registered at the city clerk's office, Toronto, 85 births, 35 deaths and 12 marriages.

The Countess of Aberdeen will leave on May 26 for England, and will visit Scotland and Ireland, returning in July.

There will be a garden party to meet the members of the Royal Society at the Government House, Ottawa, on Thursday, May 24.

James Lafferty, an old man employed on the corporation, was found dead in the stable of the City Hotel at Tiverton Monday evening.

By a fire in Montreal on Monday in a St. Paul street stable, two horses and a man named Thomas Oshurs were killed by suffocation.

The steamer Toronto, from Montreal, with a shipment of 400 head of cattle, arrived at Liverpool on Sunday, May 20, and landed all her live stock in good condition.

The Ontario Gazette contains the following appointments: John Wesley Griffin, of Delhi, to be police magistrate for Delhi; Duncan Edward Stewart, Glencoe, to be a notary public.

A Hamilton dispatch says the gale which has been blowing on the lake since Saturday is one of the most severe of the season. The steamer Macassa and four schooners are wind-bound.

Rain was still falling heavily in Toronto on Monday, being the fifth day. The water in the Don River is very high, and there is danger that the Winchester street bridge may be carried away.

J. N. Travers, formerly manager of the Bank of Montreal at Hamilton, died in Paris, France, on Sunday. Mr. Travers had been a manager for the Hamilton branch of the bank for fifteen years.

Charles J. Higgs, the book-keeper of McCarthy, Oiler & Co., who left Toronto two or three months since, and is alleged to have stolen about \$1,000 from the firm, has been arrested in London, England.

W. G. Murdoch, Toronto, made application on Monday to the Attorney-General for a reserve case on behalf of his client, Mrs. Lottie Evans, sentenced to ten years' imprisonment for conspiracy to poison her husband.

THE GENERAL ELECTION.

Monck Conservatives Decide Not to Bring Out a Man—Political Notes.

MONCK TORIES.

DUNVILLE, May 21.—The Conservative convention met at Wellandport to-day. No candidate was placed in the field and the fight will, therefore, be between Hon. R. Harcourt, Provincial Treasurer, and the Patron candidate, Mr. Hugh Crawford.

A Windsor Family Poisoned.

WINDSOR, May 21.—Mrs. Parker is lying ill at her home on Windsor avenue, suffering with all the symptoms of poisoning. Her husband and three other members of the household were in the same condition, but all have recovered with the exception of Mrs. Parker, who is in a dangerous condition and is not expected to live. How the poisoning occurred is not clear.

Freshets and Floods!

One Pennsylvania Town From Four to Twenty Feet Under Water.

Another Submerged by the Breaking of a Big Dam.

Dunkirk and Danville, N. Y., Deluged—Philadelphia Drenched—Every Mill on the Schuylkill Flooded and the River Rising Seven Inches an Hour—Immense Amount of Property Destroyed.

FROM FOUR TO TWENTY FEET UNDER WATER.

WILLIAMSPORT, Pa., May 21.—The entire city is under water from four to twenty feet. The water is still rising at the rate of six inches an hour. All the logs at the boom which broke at 1 o'clock this morning have been swept away as well as many saw mills and houses in the lower part of the city. All telegraph and telephone communication with the outer world is now suspended, the offices being flooded and closed. In the business part of the city the water has reached a depth of eight feet, and shows no signs of receding. The rain is still coming down in torrents. The loss has already reached more than \$1,000,000, and unless relief soon comes it will be three times that amount. No trains have arrived or departed from the city for 24 hours.

A BIG DAM BREAKS.

WESTCHESTER, Pa., May 21.—The breast of the dam at Springtown broke to-day. The dam covered 50 acres, and the vast body of water swept everything before it down the valley. No deaths have been reported, but the damage to farm property is great. BRIDGES SWIFT AWAY, RAILWAYS CRIPPLED.

DUNKIRK, N. Y., May 21.—It will take many thousands of dollars to cover the damage by flood in this city alone, while reports from the surrounding country say that acres of garden land were torn out along the banks of the creek, and bridges, culverts, etc., were carried away. At Fredonia the Water street iron bridge was lifted from its foundation. Many narrow escapes from drowning are reported. While Henry Tilley, of the Solgan farm, was absent from home and his wife sick, in bed, his 3-year-old boy wandered away and was carried down by the current. All railroads in the city, excepting the Lake Shore, are badly crippled on account of washouts.

DANVILLE DELUGED.

DANVILLE, N. Y., May 21.—The water in the Canesaga is now two feet above the high water mark of five years ago. The city is a vast expanse of water as far as the eye can reach, and floating everywhere are all sorts of timber and wreckage. The destruction of growing crops is complete and the loss to farmers will aggregate hundreds of thousands of dollars. Bridges are carried away and the highways are washed out for rods in many places.

PITTSBURGH, May 21.—A dispatch from Johnstown this morning says the damage by flood in Johnstown is estimated at \$125,000. The damage along the line of the Pennsylvania Railroad between Johnstown and Altoona is placed at \$1,550,000.

The loss by flood at Bradford, Pa., is estimated at \$20,000. The waters have subsided.

At Johnstown, Pa., the water is now receding rapidly, and all danger is past. The loss by the flood is variously estimated at from \$75,000 to \$150,000.

EVERY MILL ON THE SCHUYLKILL FLOODED. PHILADELPHIA, May 21.—Since Friday night 44 inches of rain have fallen in Philadelphia. The Schuylkill River is twenty feet above low water mark at Manayunk, suburb of this city. Every mill along the banks of a river is flooded in the lower story and a general shut-down has occurred. The river is rising seven inches an hour, and the overflow is believed to be the greatest since 1869.

IN WESTERN NEW YORK.

BUFFALO, N. Y., May 21.—All Western New York has suffered great injury by the rain and torrents of the past three days. The rain still continues. It is the worst flood Olean has seen since 1865, the water rising higher than at the time of the Johnstown flood five years ago next month. Almost the entire valley of the Allegheny River was a moving sea dotted with half-submerged buildings and trees. All except the highest central point of the city was inundated in the streets of Portville the water is four feet deep. At Tonawanda everything is completely saturated. All communication with Williamsport was cut off a little before 12 o'clock to-night. The Northern Central depot is on an island. The report that there was from five to ten feet of water surging through the business streets of the city was confirmed by the operator. The Reading Railway has either lost completely or badly damaged at least twenty bridges.

FALSE ALARM.

HOLIDAYSBURG, Pa., May 21.—Reports of bursting reservoirs kept 3,000 Blair county people homeless and homeless last night. Saturday night a Pennsylvania Railroad locomotive brought the warning to Gaysport that the Kittanning Point reservoir of the Altoona City water supply had given away and the valley below would be soon covered by 200,000,000 gallons of water. A Gaysport telegraph operator later received this message from Kittanning: "The dam has burst; for God's sake tell the Gaysport people to fly." The result of these warnings was that the entire population at Gaysport, Dunsmuir and West Holidaysburg deserted their homes and spent the night on the hills. The morning the danger was announced to be over and the people returned to their homes.

TOO MUCH MOISTURE.

Lambton County Farms in Some Places Covered With Water.

SARNIA, May 21.—The heavy rains which have occurred in this district continuously for five days, accompanied by strong winds and hail, have caused great anxiety to the farmers as regards their fruit and crops. In many places the ground is covered with sheets of water, the drains being quite insufficient to carry away the water. The principal damage so far as can be ascertained at present will be to the corn and potato crops. Many of the farming districts in this neighborhood are well supplied with draining facilities and escaped serious damage; other places not so well supplied are suffering, and many crops are injured beyond estimate.

The fishing bank steamer New York was burned at Camden, N. J., on Monday morning. Loss \$55,000.

WHAT A CLIMAX

To the Career of Coxe and His Lieutenants!

Transported in the "Black Maria" to Spend Twenty Days in Prison.

WASHINGTON, D. C., May 21.—Coxey, Browne and Jones were sentenced by Judge Miller in the Washington police court this afternoon to twenty days in jail for violating the statute of the United States prohibiting the display of partisan banners in the capitol grounds, and Coxey and Browne were fined \$5 additional for trespassing upon the grass or an additional ten days in jail. At 1:40 Coxey, Browne and Jones with handcuffs on their wrists, were placed in the "Black Maria."

IN THE BLACK MARIA with a dozen white and negro workhouse prisoners (who were not handcuffed) as companions, and the van immediately conveyed them to jail.

Coxey did not relish free transportation on such a basis, and when he was told he was to be taken to the district prison on he asked to be allowed to go in a carriage, but his request was not granted, and he and his companions were compelled to ride the same as other prisoners. A score of policemen patrolled the sidewalks adjacent to the court after sentence was pronounced.

The proceedings preliminary to the passing of sentence were in line with the series of extraordinary incidents that have marked the whole trial. The police court was crowded.

Mr. Hyman, for defense, made an appeal for a nominal sentence, and then Carl Browne had his say. He began by withdrawing the appeals made in his behalf, and said he had none to make. Browne proceeded in his usual blasphemous strain for some time, comparing the jury to those who had participated in the crucifixion. In conclusion he said he asked for no mercy, but would accept his punishment cheerfully.

Coxey rose next. It was the first time, he said, that he had ever stood before a court for sentence, and it was a pleasing thought that he was innocent of the charge. He told how the arrest was made and maintained that he was not walking on the grass and carried no banner. But he was not surprised that the jury brought in such a verdict, and he blamed the newspapers for it in representing his commonwealth as a band of desperadoes. "I do not appeal for mercy, because I have committed no crime," he said; "but I do ask for justice."

The assistant district attorney asked the judge to impose a jail sentence and not to impose a fine, which would be paid by the contributions of ignorant men.

Judge Miller entered into a long review of the case. He arraigned Coxey severely. There were no politics in the case, no prosecution of Mr. Coxey for his ideas. Judge Miller then imposed the sentence of twenty days' imprisonment in the district jail for all three defendants, and \$5 fine or ten days additional imprisonment for Coxey and Browne.

The effect of Coxey's conviction on his camp followers, already demoralized by drenching rain storms, insufficient food and shelter and repeated changes of base, will probably be their entire disintegration. Even now the "army" is mostly made up of idle negroes recruited in Washington and Maryland, and has scarcely any of its original members left.

CONCISE CULLINGS.

The King of Wurttemberg has announced emphatically on his own behalf and on behalf of his Government decided opposition to the late readmitting the Jesuit order into Germany.

Mr. James E. Huddart, the promoter of the Canadian Pacific mail route to Australia, on Saturday inspected Milford Haven, with a view to ascertaining its advantages as a harbor.

On Saturday during a severe tempest the barn at Gray Gables, Bourne, Mass., belonging to President Cleveland, was struck by lightning, but the damage was very slight.

The Ontario Wood Pulp Company, of New York, was incorporated at Albany on Monday, with a capital of \$50,000. The company will manufacture pulp in the Provinces of Ontario and Quebec.

A Methodist Minister on Dancing.

TORONTO, May 21.—At a meeting of the Methodist ministers of the city this morning, Rev. Thomas Manning advised that the foot-note in the Methodist Discipline touching on dancing, card-playing and theater-going be expunged. He said that Christians should be made by conviction, not by rules.

Struck by Lightning.

ST. THOMAS, May 21.—During the heavy storm last evening lightning ran down a chimney of the Grand Central Hotel and along the telegraph wires, exploding in the telegraph office with the force of a cannon. The numbers in the telephone office were all knocked down about the same time. Lightning struck the barn of George Taylor, of South Yarmouth, four miles southeast of the city, killing a steer which was standing in the yard. The siding on the barn was somewhat riddled.
