I underservants who have been ten years in the service, or under, will go out of the superannuation list altogether, the Government repaying those who have been on it the amount of their contributions. All civil servants who have been over ten years in the service will be continued as at present, except that they will be given the option of taking advantage of the new system inaugurated by the bill. The new measure provides for a fund being started, to which Government employes shall contribute a percentage. On the retirement of an officer, he will be paid this amount, with compound interest, and if he dies in the service, his widow o relatives will be entitled to the money The new law is conceived in the public interest, and though in some respects less advantageous to the civil servant, because fairer to the taxpayer, it remedies an admitted evil. Hith erto, when a civil servant died, the entire amount contributed by him remained in the public purse. If the officer lived, in due course he had a comfortable income; if he died, his widow and children were not entitled to a cent of his contributions. This inequitable disposal of a civil servant's money will now cease.
