The Sick and Funeral Benefits.

The Sick and Funeral Benefits are optional.

The Benefits are as follows:—(1) During each separate convalescence, a payment of \$2.50 a week for the first two weeks, \$5.00 a week for the next ten weeks, and at the discretion of the Executive Council a further sum of \$2.50 a week for the next five weeks. (2) A payment of \$100 for the funeral expenses of the member's death.

To secure these benefits it is necessary to pay an Enrollment Fee of \$1.00 and a Regular Ass. Fee of \$1.00. The rates for monthly assessments are as follows:
