Royal College of Physicians and Surgeons; Canadian Medical Association; Canadian Public Health Association; Department of National Health and Welfare; Dominion Council of Health; National Federation of Canadian Universities.

The organizational stage in the institute is almost completed and the first official appointments will be made by the various national organizations or associations at their annual meetings to be held during the next two months.

All universities and research centres have been notified to submit applications for grants before June 1 for the present year. Requests for assistance, already received by the institute, amount to approximately \$200,000 and the majority of these requests indicate that they will have to be continued for a period of years in order to attract first-class personnel and retain their services for a sufficiently long period to complete their several projects. Not all research centres have had an opportunity to file their applications and thus it may be assumed that the annual recurring budget for research alone will amount to approximately \$300,000.

No public appeal has yet been made on behalf of the institute. On inauguration the sole assets of the institute consisted of a grant from the King George V silver jubilee cancer fund, amounting to \$150,000 each year for three years, subject to the annual approval of the trustees of the King George V fund.

The permanent headquarters of the institute is, in the first instance, located at Ottawa, and permanent administrative staff will be appointed by the voting members of the institute at the first meeting after their appointment.

- 3. Yes. The provincial departments of health through various foundations or commissions have set up cancer diagnostic clinics and treatment centres.
- 4. Funds are available through the national research council for cancer research. Under the dominion proposals to the provinces, special reference to cancer research is made in the health grants under the health insurance section. The national cancer institute has not yet been in a position to formally request financial aid from the government apart from the sum voted by the trustees of the King George V silver jubilee cancer fund.
- 5. Graduate fellowships for physicians, chemists, biologists or other trained research workers will be made available by the National Cancer Institute of Canada after the projects and personnel have been approved by the

scientific advisory committee of the medical Research Division of the national Research council.

6. The faculties of medicine in the Canadian universities and the special provincial diagnostic and treatment foundations or centres are equipped to provide facilities for post-graduate training in this field.

#### IMMIGRATION-DISPLACED PERSONS

## Mr. WINKLER:

- 1. How many applications for immigration to Canada have been accepted up to May 1, 1947, for which as yet there was no transportation?
- 2. What is the procedure when an inmate of a displaced persons camp in Germany wishes to contact Canadian immigration officers with the purpose of applying for entry into Canada?
- 3. Under section 3 of the Immigration Act, subsection (e) where a member of a family wishing to migrate to Canada is physically unfit for reasons caused by war, to pass the medical examination, what procedure may relatives now in Canada use to satisfy the minister such invalid will never become a public charge?

### Mr. GLEN:

- 1. Information not available.
- 2. Applications for the admission to Canada of displaced persons are filed by relatives. Arrangements for their examination by immigration teams in Germany and for transportation to Canada is made by the intergovernmental committee on refugees.
- 3. The department conducts an investigation on the result of which admissibility either with or without security is determined.
