Inquiries of the Ministry

Hon. Roger Teillet (Minister of Veterans Affairs): Mr. Speaker, I wish to thank the hon. member for giving me notice that he would ask this question. The fourth report of the standing committee on veterans affairs supported the recommendations made by Dr. Richardson in his report of January, 1966, on the problems and disabilities of Hong Kong veterans. His recommendations were already being implemented, and this required a detailed review of the record of every Hong Kong veteran.

The review is well advanced but has not been completed, because it has been found necessary to examine veterans who have previously been unwilling to report for examination, and others who have not been seen in recent years. The commission is now studying the committee's further recommendations, which are supplementary to and conditional upon completion of the above review, with a view to determining how they may be implemented.
