# REQUEST FOR NATIVE INDIAN REPRESENTA-TION AT CONFERENCES

**Right Hon. P.-E. Trudeau (Prime Minister):** I do not know of the request, Mr. Speaker, but if the hon. member is referring to the constitutional conference to be held two weeks from now, there is no question of anyone but representatives of the federal and provincial governments sitting there as delegates.

**Mr. Simpson:** A supplementary question to the Prime Minister, Mr. Speaker. The Prime Minister says he knows nothing of this request. I understand the request may be forthcoming to him today. I am asking whether he will give it his fullest consideration.

Mr. Speaker: Order, please. I wonder whether it is in order to ask a minister whether he will give consideration to submissions which will be made to him at a future date or a future hour. I have some doubts about that.

**Mr. Simpson:** I have a supplementary question to the Minister of Indian Affairs and Northern Development, but in his absence I should like to direct it to his parliamentary secretary. Will the government recognize the National Indian Brotherhood as the official Indian advisory body to the department of Indian affairs; and if so, can he assure the house that the National Indian Brotherhood will not be bypassed as previous so-called advisory groups have been bypassed?

**Mr. Speaker:** Order, please. The question asked by the hon. member contains allegations, and as such cannot be accepted.
