INDIA-PAKISTAN AGREEMENT—SUGGESTED EXPRESSION OF GRATITUDE OF CANADIANS

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, I share the views of the hon. gentleman on the Indo-Pakistan war, its consequences and the great change that has taken place in relatively few days in the attitude toward a settlement. I had an opportunity of expressing similar views to representatives of both these
