# AMENDMENT TO WIDEN CATEGORY OF PERSONS ENTITLED TO LOANS

On the order: Introduction of Bills:

March 14, 1974—Mr. Reynolds—Bill entituled: "An Act to amend the Canada Student Loans Act."

Mr. Speaker: The hon. member for Burnaby-Richmond-Delta has given notice of his intention to move first reading of a bill to amend the Canada Student Loans Act. The Chair has had a preliminary look at the proposed bill and, even with a preliminary look, has very serious doubts whether it is acceptable from a procedural standpoint. The hon. member in his proposal seeks to extend the provisions of the act so as to widen the category of persons who may become the beneficiaries of loans under the act. It seems to the Chair that this provision would create an additional charge upon the treasury. I do not want to be unfair to the hon. member. It may be that he has some argument to submit in support of his bill from a procedural standpoint and perhaps the matter could be allowed to stand today and the hon. member could look at the procedural aspect. As he knows, the difficulty is that he does not have the royal recommendation. If, in the meantime, he could go to His Excellency and receive from him a recommendation, that would assist the Chair considerably and the hon. member also.
