BANK OF MONTREAL GETS MONTREAL LOAN

Montreal, March 27.—Tenders for the Bank of Montreal loan of \$1,000,000 for forty years at 4 per cent were opened today, when eleven tenders were put in, showing a great variety in figures.

The highest bid was that of the Bank of Montreal, which offered to take the whole loan at 4.25, while Coutts' Bank, of London, England, ran them a close second with 4.50 for the whole amount, the difference between the two offers only amounting to twenty-five cents on each \$100.

While the contract was not awarded there is little doubt that the Bank of Montreal will get the loan, unless they offer to divide it with Coutts' Bank. The other tenders ran as low as 4.80, which was offered for the whole loan by Amellus Jarvis & Co., of Toronto, or almost three percent lower than the offer of the Bank of Montreal.

While the offers were considered good in the present state of the market, they showed a notable falling off since the last year for forty years at 4 per cent was asked. This was for \$300,000 in 1905, and bought 105.17.

SCOTT ACT PROSECUTION IS SET FOR APRIL 30.

Fredericton, March 27.—Mrs. Penny Grant, alias Smith, who was arrested Saturday evening for theft at Lewiston (Me.) was taken to that city last evening by Detective Odlin.

In the York county prolate court, on application of J. W. McCreedy as executor of the will of the late Thomas Staples, of St. Mary's Ferry, in solemn form. The estate consists of personal property valued at \$3,150, which under the will is bequeathed to the son and daughter, A. G. Staples of St. John, and Mrs. Harriet Forest of St. Mary's. There are three other sons in the United States, and two of these, Edward and Warwick, have filed a caveat protesting that the will is invalid.

The will of Mrs. Geo. Gilman has been filed and the estate valued at \$2,500. It is to be divided among numerous relatives; \$200 was bequeathed to the trustees of the Methodist church.

Mayor Nadeau, of Madawaska, who has been in the city for the past few days on business, was also here as representative of Messrs. Cyr and Baker, M. P. P.-elect. These men ran as independent Liberals, and they are willing to support Premier Hazen, the condition being that they have the patronage in Madawaska. Mr. Nadeau left for home this morning, and was not, it is said, any too successful.

The election for the repeal of the Scott Act in this city is fixed for Thursday, April 30.

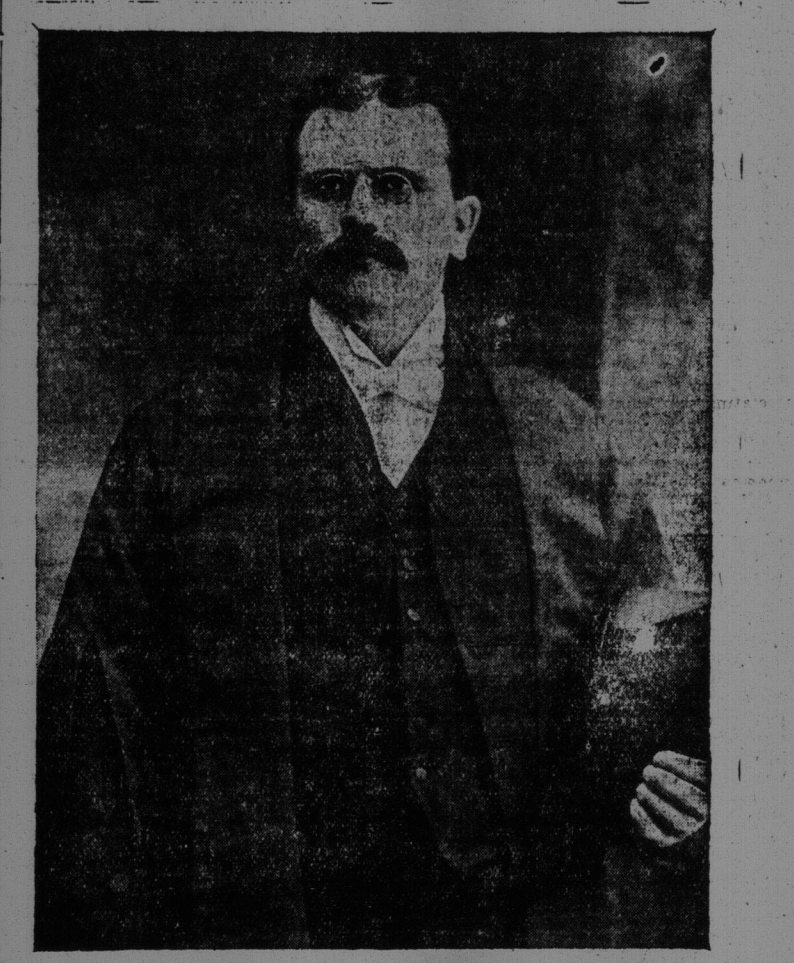

REPORTED THAT MINISTER OF MARINE WILL RESIGN



HON. L. P. BRODEUR, MINISTER OF MARINE AND FISHERIES

Ottawa, March 27.—The Ottawa Free Press, the local Liberal organ, says: "There is a rumor in well informed political circles this afternoon which receives added strength from the gossip current concerning this morning's Liberal caucus to the effect that Hon. L. P. Brodeur will be long tender his resignation as minister of marine and fisheries."

"The government will probably appoint a royal commission to investigate the charges made against the department by the civil service commission and such commission will commence its enquiries as soon as possible."

"Rumor says that if Mr. Brodeur resigns he will go to the supreme court bench to replace Justice Gwynne, who is now absent on leave of absence. Should Mr. Brodeur go out he will probably be succeeded as minister of marine by Honore Gervais, M. P. for St. James division of Montreal. It is also said there are strong probabilities of Mr. Brodeur entering the ministry without portfolio."

The following in the Liberal government organ here tonight is very significant:

"A Liberal caucus was held this morning with P. H. McKeown of Bruce in the chair. There was a long discussion over the political situation and the outlook."

THE BILLIARD CHAMPIONS

Chicago, March 27.—Calvin Demarest, of Chicago, tonight won the national amateur 142 billiard championship and at the same time established a new record for the high run, making 202 in his tenth inning. His opponent was H. A. Wright, of San Francisco, who played badly and was only able to collect 22 in his 12 trials.

Demarest's average was 30.103 and Wright's 10.22.

Madison Square Garden, New York, March 27.—Willie Hoppe of this city won the world's championship at 152 ball line billiards by defeating George Sutton of Chicago, by a score of 530 to 272 tonight at Madison Square Garden.

A MEXICAN TOWN WIPED OUT BY AN EARTHQUAKE

Mexico City, March 27.—Chilapa, a town of 15,000 inhabitants, in the state of Guerrero, has been shaken by an earthquake and burned.

The shocks, two in number, occurred early last evening and were followed by fires which originated in a dozen places among the tumbling buildings, joined in a conflagration that swept the town. Only meagre facts of the disaster are known here and what has been learned has dribbled in from half a dozen sources more or less authentic.

The loss of life, if any, as well as the monetary extent of the property damage, is not known.

is problematical and continued efforts to gauge the catastrophe have been futile tonight. Telegraph communication with Chilapa was severed by the shocks and the town is two days by horseback from the nearest railway station.

Couriers have been despatched to Chilapa from Chilpancingo, some forty-five miles distant, and it is presumed that messengers for relief were sent from the burned city early today and possibly immediately after the earthquake last night.

The reports that have reached here agree that the town was destroyed by the shocks and fire, and that the people fled the place, terror stricken.

WEST END CASES TAKEN UP AGAIN

The Gordon and Sleeth & Quinlan cases against the city were before Mr. Justice McLeod in chambers yesterday. Hearing will be continued today.

On his honor's opinion being given after the former hearing of the action, the plaintiffs appealed to the supreme court at Fredericton. A new trial on certain branches of the case was ordered, and is now being heard.

The plaintiffs claimed that they should be recompensed for filling in the water lots. His honor found against them, and on appeal it was determined by the full bench that while Judge McLeod's finding was substantially right, the plaintiffs should be paid for piling and flooring on the piling used in the filling in. The matter was therefore sent back to Mr. Justice McLeod to assess the value of the work and to add the amount which his honor should find to be due the plaintiffs to the previous assessments made by him.

Hon. H. A. McKeown, C. C. represented the plaintiffs and Recorder Skinner represented the city.
