#### SMALL BUSINESS

#### FINANCING REVIEW—PRIORITIES AND NEEDS

Hon. Ron Huntington (Capilano): Madam Speaker, my question is directed to the Minister of State for Small Businesses and Tourism. The minister has spent \$1.2 million directly and a little over \$800,000 in indirect expenditures on a small business financing review which has been under way for over two years. From twelve major reports he has produced a 77-page overview which, apart from the business sector profile of clusters, is probably the most poverty-stricken report in terms of conclusions ever produced by the Government of Canada.

As the Minister of State for Small Businesses and Tourism has had access to the 12 reports for some time, can he tell us what are the priority issues and needs of the business community in Canada?
