

MCQUEEN, JOSEPH AVARD. (*Westmoreland.*)

Youngest s. of Hon. Angus McQueen, now High Sheriff of the County of Westmoreland. B. 10 Nov. 1862 at Point de Bute. Ed. at Common School and at Mount Allison Coll., Sackville. Unmarried. Is a merchant. First returned to Ho. of Assem. at a bye election held 14 Feb., 1891. A Liberal.—*Point de Bute, N.B.*

MELANSON, OLIVER M. (*Westmoreland.*)

Of Acadian descent. B. at Shediac, 2 July, 1854. Ed. at Parish Schools. M., 12 Feb. 1878, Miss Marguerite Brendeau. Is a merchant. Was a County Councillor for three years. First returned to Ho. of Assem. at last g.e. A Liberal Conservative.—*Shediac, N.B.*

MITCHELL, Hon. JAMES, Q.C., M.A. (*Charlotte.*)

S. of William Mitchell, a native of Inverkip, Renfrew, Scot., who came to N.B. in 1827 and settled at Scotch settlement, York Co. B. there 16 March, 1843. Ed. in the Common Sch., afterwards at the Collegiate Sch., and at the Univ. of New Brunswick, Fredericton, where he graduated. M., 17 Dec. 1873, Miss Ryder of St. Stephen, N.B. Called to the Bar, N.B., 1870. Apptd. Q.C. by Dom. Govt. 4 Feb. 1891. Is a mem. of the Senate of the Univ. of N.B. Was Inspector of Schools for Charlotte Co. from 1872 to 1875, and from 1877 to 1879; has been Secretary of St. Stephen School Board and was a Census Commr. in 1881. First returned to the Ho. of Assem. at g.e. 1882. Apptd. a mem. of the Ex. Council and Surveyor-General 3 March, 1883. Resigned Surveyor-Generalship and was apptd. Provl. Secty. Receiver General and Commr. for Agriculture Feb. 1890. Re-elected by acclamation, 26 Mar., 1883, and re-elected at g.e. 1886 and 1890, by acclamation. A Liberal Conservative.—*St. Stephen N.B.*

MURRAY, WILLIAM. (*Restigouche.*)

Father, a native of P.E.I., settled in Campbelltown, in 1848. B. in Campbelltown, 13 Feb., 1857. M., 25 Nov., 1885, Gertrude, dau. of O. A. Barberie. Is a practising Barrister, Secy-Treas. of the Addington Agric. Soc. and manager of the *Restigouche Pioneer*. Has been a County Councillor. First returned to Ho. of Assem. 15 June, 1885, on appt. of sitting mem., Mr. Barberie,
