BRODER, ANDREW. (*Dundas.*)

S. of Wm. Broder, a native of Kilfree, Co. of Sligo, Irel. Mother, a native of Belfast. B. in Franklin, Co. of Huntingdon, P.Q., in 1845. Ed. there and at the Academy, Malone, N.Y. Is a merchant, and is W.M. of Dundas Co., Orange Lodge. First returned to Leg. Assem. at g.e. 1875. Unseated on petition and re-elected Oct. 1875. Re-elected at g.e. 1879 and again at last g.e. A Conservative.—*West Winchester, Ont.*

CALDWELL, WILLIAM CLYDE, B.A. (*North Lanark.*)

S. of the late Alex. Caldwell, a native of Scot. B. at Lanark, Ont., 14 May, 1843. Ed. there, and graduated at Queen's Univ., Kingston, 1865. Is extensively engaged in lumbering. First returned to Leg. Assem. in 1872. An unsuccessful candidate at g.e. 1875. Re-elected at g.e. 1879 and again at last g.e. A Liberal.—*Lanark, Ont.*

CARNEGIE, JOHN. (*West Peterborough.*)

Only s. of John Carnegie, Esq., who came to Can. from Scot., and settled in the Tp. of Douro, Co. of Peterboro', in 1833, by Charlotte C. Thomson, his wife. Grands. of John Carnegie, Esq., of Edrom, Newton, Berwickshire, Scot., a Magistrate of that County. B. in the Tp. of Donro. 23 April, 1837. Ed. at the Peterboro' Grammar Sch., and at the High Sch., Brantford, Ont. M., 1st in 1858, a dau. of Lieut. Hilliard of H. M.'s 5th Foot; 2nd, Frances, dau. of Wm. Snyder, Esq., Peterboro'. Is joint editor and proprietor of the *Peterboro' Review*, (Daily and Weekly) and of the *Canada Lumberman*. Is a dir. of the Ontario Mutual Assur. Co.; Sec.-Treas. of the West Riding Agricultural Soc., and of the Peterboro' Town Trust; Sessional Clerk of the Co. Council; Auditor of the County Criminal Accounts, and representative of the dist. on the Provl. Board of Agriculture. Has been Reeve of Douro. First returned to Leg. Assem. for present seat at g.e. 1867, and an unsuccessful candidate at g.e. 1871. Re-elected at last g.e. A Liberal Conservative.—*Glen Morrison, Peterborough.*
