with proceed to provide through provincial governments and municipal councils the means necessary to make it possible for those in need to avail themselves of medical, hospital and dental services and thereby enlarge the scope of usefulness of members of those professions who have been trained to render these much required services, and that the cost of such services be equitably distributed among all citizens according to their respective incomes.

#### Immigration.

While recognizing the numerically small population in Canada in comparison with the size of established Governmental equipment, transportation facilities and home building scope of the country, we request that until your Government has found a way to absorb into gainful employment those who are now charges of the nation, has provided the means to retain in Canada the natural increase in population, and rehabilitated dispossessed farmers and those living on land unsuited to the purpose of providing a living, that no new settlers be brought to Canada.

#### Central Bank.

The United Farmers of Canada having in the past constantly advocated the establishment of a publicly owned national bank of issue, again reiterate our request that your Government proceed forthwith to nationalize the Central Bank of Canada, with the power to issue at cost all necessary credit for relief requirements and public development, national, provincial and municipal.

#### Insurance.

During the past six years many citizens of Canada have lost their insurance and recognizing that the sphere of insurance is irrevocably bound up with any government system of unemployment insurance, old age and widows' pensions, public works, etc. we urge that in order that an inexpensive insurance scheme may be provided, that your Government extend the scope of the government annuities Act being Cap. 7 of R.S. Canada, to permit the sale to any Canadian, within a specified age limit, whether disabled or not, and without examination, insurance up to the amount of \$2,000 and that such insurance shall be based on actuarial rates to be sold at cost to any naturalized Canadian, plus a small sum to cover operating charges, and that such policies shall be purchasable at any town or city post office, throughout the Dominion of Canada.

#### Radio.

Much complaint has been expressed of the misuse of radio broadcasting during recent elections, we, therefore, request that your Government consider a policy for equitable radio broadcasts by federal political groups from the time of election proclamation to enable each group to declare its particular policy, and that cost of same be borne by the Dominion treasury, all addresses to be first submitted to a committee representative of each party in the House of Commons for approval or otherwise.

#### Electoral reform.

The recent provincial and federal elections clearly evidenced the unfairness of the present method of balloting in that while one provincial political group received an aggregate vote of approximately 30% of the voting electorate, not one seat is occupied by that group in the legislature; we, therefore urge upon your Government to establish throughout Canada the single transferable method of balloting in all federal elections; and in the interests of uniformity, that other than single seat
