### Deaf and Dumb Institution.

(Gottingen Street.) This Institution has been in operation for thirty-four years. It is supported partly by grants from the governments of the Maritime Provinces, and partly by voluntary contributions. By Act of the Provincial Legislature of April 19th, 1884, every Nova Scotia deaf and dumb mute child of sound mind between the ages of eight and eighteen is entitled to free admission to this Institution on the order of the Warden of the Municipality to which the child's parents belong.
