### General Intelligence.

#### Earthquake in England.

LONDON, April 22.—A severe shock of earthquake was felt in several of the eastern counties at nine o'clock this morning. A number of church steeples and chimneys were thrown down, houses were unroofed, and many buildings had their walls badly rent, while the furniture in the residences and offices, together with the fixtures of stores and the windows, were broken. No lives are as yet reported lost, though it is known that several persons were severely injured.

LONDON, April 22.—At 9.30 this morning an earthquake shock was felt in the City of London, and in the suburbs of London, and in the County of Essex. At Ipswich the walls of the houses were shaken, plates were rattled and bells rung. People were thrown into such a state of consternation that business was suspended. The shock was still more severe in Colchester. The damage is great. A minute. The first symptom was a deep, rumbling sound; this was speedily followed by the quaking and shaking of the buildings.
