SOLDIER SETTLEMENT PAYMENTS

2. No. Crop failures have occurred intermittently in scattered localities from various causes, such as hail and grasshoppers.

3. The boundaries of the drought area in Canada are approximately as follows:-

In Alberta, beginning on the International boundary at approximately range 22, west of the fourth meridian, south of Lethbridge, extending northwest to Irricana then following an irregular arc northeast to Stettler, Wainwright, and along the Battle river to the Saskatchewan boundary.

In Saskatchewan, following the Battle and North Saskatchewan rivers to township 39, range 7, west of the third meridian, approximately 40 miles northeast of Saskatoon, then south and east to the Qu'Appelle river about north of Regina, and along this river to the Manitoba boundary.

In Manitoba (with the exception of 1937), following the Qu'Appelle and Assiniboine rivers to Brandon and then southeast to the vicinity of Morden.
