TAKEOVER OF CHECKERBOARD FOODS BY SWIFT CANADIAN— REQUEST FOR REPORT

In view of the conflicting and apparently premature reports appearing in the national press and emanating from the minister's department concerning the long awaited decision on the proposed takeover of Checkerboard Foods by Swift Canadian Company Limited, will the minister clarify the present status of this application?

Hon. Donald C. Jamieson (Minister of Industry, Trade and Commerce): Mr. Speaker, the decision is that in so far as the Foreign Investment Review Agency is concerned, and those matters which come within its jurisdiction, there is no impediment to allowing this particular transaction to take place. There is, however, a question relating to a potential offence against the Combines Act—I suppose one might describe it as that—and this is now being considered by the Department of Consumer and Corporate Affairs.
