Supplementary Estimates (B)

- (f) land and property of substantial value or from which a substantial income is derived; and
- (g) the names of companies or other bodies in which the Member has, to his or her knowledge, either himself or herself or with or on behalf of his or her spouse or dependents, any beneficial interest including—among others, share-holderings—of a nominal value greater than one-hundredth of the total capital assets of the company or other body;

and that it report on the form and content of such a Register not later than December 31, 1985; and

Provided, that notwithstanding the usual practices of this House, if the House is not sitting when the final report of the Committee is completed, the Committee shall report its findings by depositing the said report with the Clerk of the House and it shall thereupon be deemed to have been laid upon the Table.
