Hon. Benoît Bouchard (Minister of Transport): No construction for new runways has been undertaken at Lester B. Pearson International Airport.

Any new runway construction will not be undertaken until after the Environmental Assessment and Review Panel process has been completed.

The only airfield construction works underway at Lester B. Pearson International Airport are to improve existing taxiway configuration.

*Question No. 168-Ms. McLaughlin:

Has the government estimated the cost of (a) tearing down a portion of the Federal Building in Whitehorse and refurbishing the remainder with new infrastructure (such as water and heating, among other things) (b) tearing down the entire Federal Building and building a new structure which would meet the needs of the federal government in the Yukon and, if so, what is it?

Hon. Elmer Mac Intosh MacKay (Minister of Public Works): The estimated cost to:

(a) tear down a portion of the Federal Building in Whitehorse and refurbish the remainder with new infrastructure is \$24,699,000; and

(b) tear down the entire Federal Building and build a new structure was not considered a variable option since major amounts of leased space are not available. This option would require a program of phased construction over a prolonged period of time. This in turn would create significant tenant disruptions and discomfort.
