Government to punish the authors of Indian outrages on the Klamath river. He suspected the Modes of being the guilty parties, invited a large number of their most prominent men to a conference, and offered them poisoned meat.

When starvation at last stared them in the face they returned to their old home, where they maintained themselves by fishing and hunting. They were not better neighbors, and they wanted no better neighbors, and two authorized Government Commissioners, in 1871, held a conference with them.

They must be removed to a reservation and kept together, they might be Christianized. So the order was given to drive the Modes back to freeze and starve in the midst of the hostile Klamaths—an order in direct violation of the engagements of the Government.

The Indians became desperate and resisted the force sent to their reservation. They were hunted from cave to cave by the forces of the United States, and many were the reprisals experienced by the military. Reinforcements went forward, infantry, cavalry and artillery covered the region, and the Chief and his band of thirty Indians, with their families, children, obtained subsistence, preserved their freedom, and inflicted considerable punishment on their pursuers.

The moral of the story is that the policy of justice to the Indians, inaugurated by the British Government, and maintained by the Government of the Dominion. Oppressive greed, under the name of enterprise and civilization, must not drive the Indians to desperation. Our desire for the saving of the souls of the Indians must not lead us to ask them to sacrifice their bodies on inhospitable reservations. Our Government must look sharply after its agents, and prevent their doing injustice to the sons of the forest. The policy of the future must be that of the past—justice, moderation, and firmness. Indians must be made to value our friendship and trust our promises, and fear only our resentment of treachery and outlawry.

Shipping Notes. The steamer Severn Disabled.—The steamer Severn, of the Temperley Line, Campbell master, which sailed from this port a few days ago for Montreal, in ballast, passed Halifax on the 2nd inst., handling her pilot at Thrupp Cap. After proceeding some distance her propeller worked loose, and the Captain decided to make for Halifax under sail. Arriving at that port on the 3rd, a boat was sent ashore at Sambro, and assistance telegraphed for to the city. A tug boat was at once sent down and the disabled steamer towed into port. She is now anchored off the Marine Railway, at Dartmouth.

The Elmor Chapman, from Waterford, Ireland, for this port, 75 days out, was spoken on the 29th August, by the Isaac Goodwin, Smith master, at Cape Island, short of supplies.

The Lavour, Barkard, master, which arrived at Broughda, from this port, previous to the 20th ult., had lost part of her deck load.

The Ship Jane Duncan, Kitchin master, which arrived at Liverpool, E., on the 23rd ult., from Charlottetown, P. E. I., reports that on the 15th, during a strong N. W. gale, 10 miles S. E. of Arrau Isle, the vessel took a lurch to leeward, when her mizzenmast went by the board, and her mizzenmast by the boards. The ship being disabled was driven into Gwiltchara Bay, where she was brought to an anchor in Churchpool. The assistance of the coastguard at that place was offered, but was not required.
