Apptd. senior mem. of the Ex-Council for North-West Territories, Dec., 1872. An unsuccessful candidate for Montarville in L. C. Can., 1858, and for Hochelega in Can. Assem., 1862. Represented St. Boniface in Manitoba Assem., for which he was first returned by acclamation, Dec., 1870. Elected by acclamation for Baie St. Paul g.e., 1879. Called to the Senate on Manitoba entering the Dominion, 13 Dec., 1871. A Conservative.—*St. Boniface; Manitoba Club, Winnipeg.*

GLAZIER, Hon. JOHN.

B. in Lincoln, Sunbury, N.B., 3 Sept., 1809. Ed. there. A lumber merchant. A dir. of the Fredericton Railway Co. Sat for Sunbury in N. B. Assem. for some years prior and up to the Union, and afterwards, until apptd. to the Senate, 14 March, 1868. A Liberal.—*Lincoln, Sunbury, N. B.*

GOWAN, Hon. JAMES ROBERT, LL.D.

Only s. of the late H. H. Gowan, Esq., who, emigrating from Irel., settled in the Tp. of Albion, and became Clerk of the Crown and Pleas, Co. Simcoe. B. in Co. Wexford, Irel., 22 Dec., 1815. Ed. in Can. Admitted to the Law Soc. of Upper Can., 1833. Served during the Can. Rebellion 1837-8 as Lieut. in 4th Reg., North York Militia. M., 1853, Anna, dau. of Rev. S. B. Ardagh, M.A., Rector of Barrie. Called to the Bar U. C., 1839, and apptd. Judge of the Dist. of Simcoe, 17 Jan., 1843, a position he held until his retirement in Oct., 1883. Received Hon. degree of LL.D., Univer. of Queen's Coll., 1884. Much of the reform and regulation of the legal procedure of the several courts in Ontario is due to him. Assisted in the consolidation of the Statutes of Can. in 1858 and 1859; in 1869 in the consolidation of the Criminal Law, and in 1876 in the consolidation of the Statute Law of Ontario. Was the Judicial mem. of the Board of Arbitrators apptd. to settle the differences between the Govt. and the contractors for the Public Buildings at Ottawa; Chairman of the Board of Judges for Ont., 1869 to 1887; a mem. of the Commission to inquire into the constitution and jurisdiction
