Reported with Amendments, 100. Committed; Amended; Reported, 121. Motion (on Order for consideration being read) that the Bill be recommitted for the purpose of providing that any man who shall, under promise of marriage seduce any unmarried female of previous chaste character, shall be guilty of a misdemeanor, &c., 141. Agreed to; Bill recommitted and amended; Reported; Motion for consideration; Amendment moved to recommit the Bill for the purpose of amending the 4th Clause; Debate thereon adjourned, 142.
