Fredericton, Thursday, 1st February, 1844.

THE HOUSE having been by several Proclamations prorogued until this day, then to meet for the dispatch of business ; and being met—

A Message was received from His Excellency the Lieutenant Governor, by the Gentleman Usher of the Black Rod, requiring the immediate attendance of the House in the Council Chamber.

The House attended, and being returned—

The Honorable Mr. Speaker reported to the House ;—That during the recess it had been certified to him by Charles Fisher and James Taylor, Esquires, two of the Members of the Assembly for the County of York, that Lemuel Allan Wilmot, Esquire, a Member for the said County, had been appointed to and accepted of a Seat in Her Majesty's Executive Council in this Province ; by reason whereof the Seat of the said Lemuel Allan Wilmot, Esquire, as a Member of the Assembly, had, under the provisions of an Act made and passed in the fifth year of the Reign of Her present Majesty, intituled "An Act to vacate the Seats of Members of the Assembly in certain cases," become vacated ;—That in pursuance of the provisions of the said Act he had issued his Warrant to the Clerk of the Crown in Chancery, requiring a new Writ to issue for the election of a Member for the said County of York, in the place of the said Lemuel Allan Wilmot, Esquire ; whereupon

On motion of Mr. Allen,

Ordered, That the Clerk of the Crown in Chancery, or his Deputy, do forthwith attend this House with the Writ issued to the Sheriff of the County of York, for the election of a Member for the said County, in the room of Lemuel Allan Wilmot, Esquire, who has been appointed a Member of Her Majesty's Executive Council.

The Honorable Mr. Speaker further reported to the House ;—That during the recess it had been certified to him by William H. Street, Esquire, a Member of the Assembly for the City of Saint John, and John R. Partelow, Esquire, a Member for the County of Saint John, that Robert L. Hazen, Esquire, a Member for the said City, had been appointed to and accepted of a Seat in Her Majesty's Executive Council in this Province ; by reason whereof the Seat of the said Robert L. Hazen, Esquire, as a Member of the Assembly, had, under the provisions of an Act made and passed in the fifth year of Her present Majesty's Reign, intituled "An Act to vacate the Seats of Members of the Assembly in certain cases," become vacated ;—That in pursuance of the provisions of the said Act, he had issued his Warrant to the Clerk of the Crown in Chancery, requiring a new Writ to issue for the election of a Member for the said City of Saint John, in the place of the said Robert L.
