2. *Resolved*, That a sum not exceeding Fifty-six thousand dollars be granted to Her Majesty, to defray contingent expenses for Stationery, Printing, inspecting and repairing of Arms, transport of all Government Stores, and all other incidental expenses of the Militia; for the financial year ending 30th June, 1867.

3. *Resolved*, That a sum not exceeding Two thousand dollars be granted to Her Majesty, to provide compensation for accidents or injuries on drill; for the financial year ending 30th June, 1867.

4. *Resolved*, That a sum not exceeding Thirty thousand dollars be granted to Her Majesty, to provide against ball and blank ammunition; for the financial year ending 30th June, 1867.

5. *Resolved*, That a sum not exceeding One hundred thousand dollars be granted to Her Majesty, to defray the expenses for Military Schools; for the financial year ending 30th June, 1867.

6. *Resolved*, That a sum not exceeding Fifty thousand dollars be granted to Her Majesty, to defray salaries of two Storekeepers at Six hundred dollars, and seven Storekeepers at Three hundred dollars each, amounting to the sum of Three thousand three hundred dollars; and for rent of Armouries and Public Buildings, care of Arms, pay of Serjeant Majors of Field Batteries, Caretakers and Storemen of Armouries, including fuel and light for the several buildings, the sum of Forty-six thousand seven hundred dollars; for the financial year ending 30th June, 1867.

7. *Resolved*, That a sum not exceeding Two hundred and eighty-one thousand dollars be granted to Her Majesty, to defray expenses for Clothing and Equipment of Militia Force and Great Coats; for the financial year ending 30th June, 1867.

8. *Resolved*, That a sum not exceeding Nineteen thousand dollars be granted to Her Majesty, to defray expenses for sixteen Brigade Majors, horse allowances and travelling expenses; for the financial year ending 30th June, 1867.

9. *Resolved*, That a sum not exceeding Five thousand dollars be granted to Her Majesty, to defray expenses for Efficient Volunteer Corps, under section 16 of the Volunteer Militia Act; for the financial year ending 30th June, 1867.

10. *Resolved*, That a sum not exceeding One hundred and ten thousand dollars be granted to Her Majesty, to defray expenses for Drill Sheds, Armouries, &c., Rifle Ranges; for the financial year ending 30th June, 1867.

11. *Resolved*, That a sum not exceeding Forty-five thousand dollars be granted to Her Majesty, for amount due Imperial Government for Stores; for the financial year ending 30th June, 1867.

12. *Resolved*, That a sum not exceeding Four hundred and twenty dollars be granted to Her Majesty, to provide for Rent of an Office, for Brigade Major *Macpherson*, at *Montreal*, from November, 1862, to 31st December, 1864, at Two hundred dollars per annum; for the financial year ending 30th June, 1867.

13. *Resolved*, That a sum not exceeding Four hundred dollars be granted to Her Majesty, to provide for arrears of Drill Shed Rent due Captain *McMaster*, at *Toronto*; for the financial year ending 30th June, 1867.
