It is 'too late to head this immigration off, even if it were desirable to do so, but in view of the fact that the government has for years been straining every nerve to add to the country's population, it would be absurd to attempt it.

If the present Dominion cabinet made up of statesmen, they will rise to a realization of the problem and by making it possible for these immigrants to secure work they will double the population of the Pacific province in one which will go over their road. year.
