The Standing Committee on Standing Orders have the honour to make their Third Report.

Your Committee have examined the following Petitions, and find that sufficient notice has been given in each case :—

Of F. E. Hartman and others, of the City of London, England, praying to be incorporated as the Velvet (Rossland) Mine (Limited), and giving them power to construct certain short lines of railway in connection with their mine.

Of the Montreal, Ottawa and Georgian Bay Canal Company; praying for the passing of an Act extending the time for the commencement and completion of their works, and for such other purposes as may be incidental thereto.

Of James Cochrane and others, of the City of Montreal, and others of elsewhere, praying to be incorporated under the name of the Medicine Hat and Northern Alberta Railway Company.

Of the Bell Telephone Company of Canada; praying for the passing of an Act granting them power to increase their capital stock.

Of W. K. George, of the City of Toronto, in the Province of Ontario, and others; praying to be incorporated as "The Canadian Manufacturers' Association."

Of the Canada and Michigan Tunnel Company; praying for the passing of an Act extending the time for the commencement and completion of their works, and for other purposes.

Of the Canada Southern Railway Company, and the Provisional Directors of the River St. Clair Railway, Bridge and Tunnel Company; praying for an extension of time for the payment upon the stock, under the terms of their Act of incorporation, and also for the commencement and completion of the works of "The River St. Clair Railway, Bridge and Tunnel Company."

Of the Canada Southern Railway Company; praying for the passing of an Act extending the time for the commencement and completion of its incompleting lines of railway and branches.

Of the St. Clair and Erie Ship Canal Company; praying for the passing of an Act extending the time for the commencement and completion of their works.

Of the Hudson's Bay and Northern Railway Company; praying for the passing of an Act extending the time for the commencement and completion of their proposed railway.

Of James McCarthy and others, of the City of Toronto, in the Province of Ontario; praying for the passing of an Act incorporating them a company under the name of "The Huron and Erie Canal Company."

Of the Central Counties Railway Company; praying for the passing of an Act extending the time for the completion of their railway, and increasing the bonding powers of the company.

Of James Pearson and others, of the City of Toronto, and elsewhere; praying to be incorporated as "The Nipissing and Ottawa Railway Company."

Of the Port Dover, Brantford, Berlin and Goderich Railway Company; praying for the passing of an Act extending the time for the commencement and completion of their railway, and to change the name of the company to "The Grand Valley Railway Company," and for other purposes.

Of the Edmonton and Slave Lake Railway Company; praying for the passing of an Act extending the time for the commencement and completion of their said railway.

Of George Duncan Wood, of the City of Winnipeg, and others of elsewhere; praying to be incorporated as the Battleford and Lake Lenore Railway Company," and

Of the Canadian Northern Railway Company; praying for the passing of an Act empowering them to construct additional lines of railway, increase their capital stock,
