2. The Harbour Commissioners carry an overdraft with their bankers on the security of advances on loan due to be made as works progress. No advances are made until an equal amount of expenditure in their prosecution has been incurred. No guarantee or promise of guarantee for repayment of any funds advanced by the bank to the commissioners has been given by the government or any department thereof so far as the Department of Marine and Fisheries is aware.

- (b) The Federal Appeal Board is composed of five commissioners of whom two are medical doctors. This board has two medical advisers.
