were made; the consideration paid; the cost to Canada of administering and developing said lands prior to transfer, and so forth. It is an order which it would take some time to prepare, but not the time that has already lansed.

Another was passed on March 2, asking for the amount of duty paid by American railway companies on American rolling stock used in Canada in the past twenty-six years; the names of such companies, the character of the rolling stock, and amounts; moved by the hon member for West York (Sir Henry

Drayton).

Another, on the same date, was moved by the hon. member for Kingston (Mr. Ross), for the report of the investigation by David Campbell, K.C., concerning coal supplies; another moved by the hon. member for Parry Sound (Mr. Arthurs) on the same date, was for a return showing the payment for services of David Campbell and D. R. MacLean during such inquiry; another, moved on March 4 by the hon, member for Kingston (Mr. Ross), with regard to the cost of the investigation held by David Campbell into such coal matters affecting military district No. 10; another moved on the same date by the hon. member for Parry Sound (Mr. Arthurs) asked for a statement of the cost of the coal inquiry at Tuxedo Barracks, Winnipeg; the amount the commissioners received, and whether the government received objection to the amount paid from Winnipeg or elsewhere.

Another moved on March 9, by the hon. member for Yukon (Mr. Black), for the correspondence respecting exemption from payment of income taxes on payments or remuneration, whether paid as salary, living allowance or otherwise, by the government of Canada to officials of the Yukon.

Another moved on the 9th of March by the hon. member for West Algoma (Mr. Simpson) with respect to the number of motor cars purchased by the government since January

1, 1912.

Another moved on the 11th of March by the hon. member for Kent, N.B. (Mr. Doucet), as to the tenure of office and names of officers commanding the military districts of Halifax, St. John, Toronto, and other military districts; another moved by the same hon. member, on the same day, for the name, rank, position and pension of each officer on the staff at headquarters at Ottawa, and so on.

Another moved on March 16 by the hon. member for Kent, N.B. (Mr. Doucet), for the correspondence between the Department of Marine and others regarding services rendered

in saving lives by Tiburce Mallet of Ste. Marie, Shippigan Islands, N.B.

Another by the hon, member for Charlotte (Mr. Grimmer) for a return for the months of May and June, 1924, showing invoiced value of importations into Canada of canning machinery leased by the Customs department.

Another moved on March 30, by the hon. member for Vancouver Centre (Mr. Stevens), for a copy of correspondence between the Department of National Defence or the Department of Justice and the Canadian Coal Sales Company, Limited.

Another moved on March 30, by the honmember for Parry Sound (Mr. Arthurs), for a copy of all letters, telegrams, papers and other documents between the government of Canada and the mine workers of Cape Breton.

Another moved on April 22, by the hon. member for South Oxford (Mr. Sutherland), with respect to the total amount spent by the present government since coming into office for public printing, aside from that done by the Printing Bureau, and other data.

Another moved on April 22, by the hon. junior member for Halifax (Mr. Black), for a copy of all correspondence, reports, documents, and so forth, passing between the Department of Justice and any other departments of the government, or ministers, or any other parties whatsoever, within the past six months, relating to the appointment of Inspector of Penitentiaries and the refusal to accept for such appointment Col. Eric W. MacDonald, of Halifax.

Another on the same day, by the hon. member for Vancouver Centre (Mr. Stevens), for a copy of all correspondence and documents passed between the governments of Roumania and Greece and the government of Canada, or the High Commissioner, regarding the adjustment of outstanding debts of these countries to Canada.

Another by the hon. member for New Westminster (Mr. McQuarrie), on April 27, for a return showing the number of civil servants eligible to come under the provisions of the Civil Service Superannuation Act, 1924—just the number.

Another on April 27, by the hon. member for Kent, N.B. (Mr. Doucet), for a copy of all correspondence and other documents in relation to the appointment of the new postmaster at St. Ignace.

Another on May 6, by the same hon. member—I am only going to give those which were passed up to a month ago; I shall not proceed on the assumption that any passed since are grossly in arrears—for all
