For the present, the C.B.C. has found it essential to give priority to similar coverage needs which can be met at substantially lower cost.

# C.B.C. TELEVISION STATION, FISHER BRANCH, MANITOBA

## Question No. 465-Mr. Stefanson:

- 1. Has the C.B.C. purchased land for the proposed television rebroadcasting station at Fisher Branch, Manitoba and, if so, from whom and at what price?
- 2. What is the estimated total cost for this television rebroadcasting station?
- 3. What is the estimated area that will receive good reception?
- 4. When does the C.B.C. expect this station to go into operation?

## Hon. Judy V. LaMarsh (Secretary of State): 1. Yes, from Mr. R. B. Barrett of Fisher Branch, Manitoba, for the amount of \$4,407.

- 2. \$306,000. This figure includes land, building, equipment, tower, engineering, contingency and provides for future conversion to colour transmission.
- 3. The "B" contour of the proposed station, which is the accepted limit for adequate coverage, extends north from Fisher Branch, approximately 45 miles, south 32 miles, east 41 miles and west 44 miles. Generally speaking, fringe reception can be attained for some miles beyond the "B" contour with a suitable antenna.
- 4. It is expected that the station will go into operation late in August or early September 1966.
