LABOUR CODE—APPLICATION TO FISHERIES DEPARTMENT VESSELS

Question No. 895—**Mr. Muir (Cape Breton North and Victoria):**

Does the Canada Labour (Standards) Code apply to employees on vessels operated by the Department of Fisheries?

**Hon. H. J. Robichaud (Minister of Fisheries):**

The act does not apply directly to employees of government departments. (See House of Commons Debates Oct. 13, 1964, p. 8999). However, standards similar to those contained in Part II (minimum wage) Part III (annual vacation) and Part IV (general holidays) of the Canada Labour (Standards) Code apply to the public service.

3. The estimated average recovery rate for all ranks is \$96. per month. This is based on \$80 for a private soldier to \$130 for a Lieutenant Colonel.

4. Subsidized housing is presumed to mean all forms of married quarters including rental agreements. On this basis 26 percent of the forces are affected.

5. A qualifying point system based on years of service and number of children is used by the Canadian army and the R.C.A.F. The R.C.N. uses a first come, first served basis. However, as integration progresses, a common allocation policy will be instituted.
