NATURE OF DISCUSSIONS BETWEEN FEDERAL AND PROVINCIAL OFFICIALS—DATE OF MINISTERS' MEETING AND SUBJECTS ON AGENDA

Hon. Marcel Lambert (Edmonton West): Mr. Speaker, my question is directed to the Minister of Finance. Would the minister advise the House precisely at what level the conference between representatives of his department and their counterparts in the provincial administrations will take place and what will be the agenda of the discussions this week? Do they tie in with the announcement made by the minister last week or do they have to do with further discussions on Bill C-259?

Hon. E. J. Benson (Minister of Finance): Mr. Speaker, the discussions that are going on are dealing with the announcement I made last week on Thursday, basically, and are preparatory to a meeting of the Ministers of Finance which is to take place as soon as we can possibly arrange it, which will be early in November.

Mr. Lambert (Edmonton West): Mr. Speaker, could the minister indicate at what target date he is aiming for the conference of ministers and will the provisions of Bill C-259, particularly those elements involving co-operation between the federal and provincial governments, be a particular part of the agenda of that conference?

Mr. Benson: Mr. Speaker, the meeting is to take place as early in November as possible. Obviously it cannot take place before tomorrow because of certain other events which are taking place. The earliest dates we have had people indicate might be possible are in very early November. Of course Bill C-259, or the tax proposals, will be part of the discussions that take place with the Ministers of Finance of the provinces, as well as the economic outlook and the proposals I announced to the House last Thursday.
