Hon. John N. Turner (Minister of Finance): In the course of considering an approach for financing and in processing a loan application, the experience and skills of the IDB staff are available to the potential borrower who often avails himself thereof. Thus, even when an application is declined the IDB may have been of some assistance. Not infrequently the IDB is able to suggest how a weakness in a loan proposal may be overcome. In a more general context, the IDB in 1972 established an Advisory Services program to help promote good management practices in small business. To this end it is holding business management seminars in smaller centres across Canada [Mr. Knight.]
