

Mr. Ross Milne (Parliamentary Secretary to Minister of Indian Affairs and Northern Development): 1. Fiddle River Campground was closed permanently in the fall of 1974. Snaring River Campground has not been closed. The Fiddle River Campground was closed for the following reasons: (a) The campground was worn out by overuse; (b) The Fiddle River Campground was operating in competition with Folding Mountain Campground located outside the Park which was run by a private operator. Parks Canada's policy is not to compete with privately-operated campgrounds adjacent to national parks.

2. In 1974, 90 new sites were opened at Wabasso Campground.

4. Plans for Snaring River Campground are to add 50 sites to the existing 60 sites at a future date. The Fiddle River Campground will remain closed.

5. Two toilets are provided at Maligne Lake (one men's, one women's). In addition, Maligne Tours Ltd. have opened their chalets for the winter and toilets are available there.

On December 6, 1977, did the government approve projects under the Local Initiatives Programs in the (a) Province of Quebec (b) Constituency of Richmond and, if so (i) how many (ii) in what major sectors (iii) what was the dollar value?

Hon. Bud Cullen (Minister of Employment and Immigration): (a) No. (b) No. Note I—The approval process for projects under the Local Initiatives Program was completed on March 28, 1977. Note II—Under Canada Works, the successor to the Local Initiatives Program, there was one project approved on December 6, 1977, in the Province of Québec. The project was approved under the second phase of Canada Works for the constituency of Laurier at a value of \$23,894.

NATIONAL FILM BOARD—"CONFLICT COMEDY" AND "RUNNING TIME" FILM PRODUCTION

Question No. 1,083—**Mr. Cossitt:**

1. Did the National Film Board produce a film for a period of over five years with the working title "Conflict Comedy" and a planned release title of "Running Time" and, if so (a) what was the exact date production (i) started (ii) ended (b) what are the names of all persons who directed the project and what position did Mr. Robert Verrall play in the production of the film (c) was the total cost of the production approximately \$1.5 million and, if not, what was the exact cost?

2. Was the film released and, if not (a) for what reason (b) what are all the reasons justifying the expenditure of considerable public funds on a film which was never released?

Hon. John Roberts (Secretary of State): I am informed by the National Film Board as follows: 1. The National Film Board has produced a film entitled "Running Time". (a) Shooting—57 days during period June 5, 1972 to June 1, 1973. Editing—between June 1973 and February 28, 1976. Test print approved—June 8th, 1976. (b) Production Team: Executive Producer—Colin Low Producers—Tom Daly, George Pearson Director—Mort Ransen. Robert Verrall was Director of English Production, August 1972 to January 1976. (c) Cost—\$1,166,260.

2. (a) The film was released for non-theatrical distribution in the Fall of 1977 and is available through NFB offices. Recently sold to CBC (English network) for national telecast. A concerted effort made to obtain theatrical release prior to non-theatrical release was unsuccessful. (b) The film in question has been released. The NFB implements its mandate by using all forms of filmic expression, from documentaries through to feature dramatic films. It also undertakes projects of an experimental nature with a view to advancing the art of film-making in Canada. "Running Time" is a feature length dramatic film, using actors, original music compositions, sets, difficult and new animation techniques and special effects.
