Wymar, John Whitten, William Walker, their several and respective heirs, executors, curators, administrators, successors and assigns, shall be, and are hereby ordained, constituted and declared, to be a Corporation, Body Corporate and Politic, by the name of "THE MONTREAL BANK," and shall so continue and have succession till the first day of June, which will be in the year of our Lord one thousand eight hundred and thirty-eight, and shall and may by the said names be persons able and capable in Law to sue, be sued, implead, and be impleaded, answer and be answered, defend and be defended, in all Courts and places whatsoever : and shall also be able and capable in Law to purchase, acquire, hold, enjoy, and retain to them, and their successors, lands and tenements, real or immoveable estates, for the convenient conduct and management of the business of the said Bank, and for no other purpose ; and may sell, alienate, and dispose of such lands, tenements, real or immoveable estates, and purchase and acquire others in their stead for the purpose aforesaid ; and may have a common seal, and may change and alter the same at their pleasure ; and may also or-
