

The Order of the day for taking into consideration the First and Second Reports of the Special Committee to which was referred the Petition of the Reverend *Francis Evans* and others, Clergymen of the United Church of *England* and *Ireland*, Diocese of *Toronto*, praying for certain arrears due them as Missionaries, being read ;
