creditor's debt in full if the creditor will sign an assent to his discharge and enable him to obtain it, and the debtor, after having thus obtained his discharge, in execution of his oral promises gives a written promise to pay the debt, the written promise is tainted with the original fraud and cannot be enforced, according to the decision of the Supreme Judicial Court of Massechusetts in the case of Tirrell vs. Freeman et al.

RAILROAD-CONNECTING LINES-LIABILITY. -The case of Pennsylvania Railroad Company vs. Council, decided by the Supreme Court of Illinois, was one in which it appeared that a passenger bought of the Wabash, St. Louis & Pacific Railroad at Omaha, a coupon ticket from that place to the city of New York, calling for passage over the road of that company to St. Louis, and from thence to New York over the Ohio and Mississippi, the Marietta & Cincinnati, the Baltimore & Ohio, the Philadelphia, Wilmington & Baltimore, and the Pennsylvania Railroad lines. The ticket has printed on its face: "In selling this ticket for passage over other roads this company acts only as agents for them, and assumes no responsibility Leyond its own line," and the coupon over the Pennsylvania declared, "Issued by the Wabash, St Louis & Pacific Railway, on account of Pennsylvania Railroad," which the company owning the latter road refused to accept, and on refusal to pay the fare demanded ejected the passenger. The court held in this suit, which was brought by the passenger against the latter company, that the first-named company contracted with the passenger only as agent of the defendant company.—Bradstreet's
