exports increasing by more than 50 per cent.

Canadian companies have been successful in selling aircraft, including the Dash-7 and the CL-215 water bomber, mining trucks, various specialized machinery, and such raw materials as asbestos, wood pulp, coal and iron ore.

Then, states the guide, Yugoslavia's shortage of hard currency and severe restrictions on imports, resulted in a decline in Canadian exports between 1981 and 1983. The following year, however, Canadian exports recovered, growing by some 55 per cent to reach \$76 million.

Now that the trade climate is more conducive to Canadian exports, the potential, says the guide, lies in the fully manufactured goods sector. This is especially true in the design and supply of equipment for the production of energy, pulp and paper, and mineral transformation.

Opportunities also exist in the communications sector, the supply of specialized measuring equipment, software services and other specialized technologies where domestic expertise has not been acquired.

Industrial transportation equipment, forestry exploitation machinery and road building equipment also represent potential opportunities for Canadian exporters.

While these opportunities seem abundant, it is not a simple matter to take advantage of

reported that, with support from the Canadian International Development Agency (CIDA), it is preparing a study on the economic viability of food irradiation in Thailand.

Officials participating in the three-day dialogue also report that the Conference Board of Canada agreed to establish "institutional linkages" with the Thailand Development Research Institute.

This agreement, they say, "is expected to lead to co-operation in joint research projects on bilateral trade and investment, on exchanges of professional staff, and the development and exchange of data bases and information that could be helpful to the private sector in both countries to improve the identification of trade and investment opportunities."

In a final development, which would give impetus to the momentum already generated by the dialogue, the Business Co-operation Branch of CIDA indicated it would consider sharing the cost of mounting a Thai Investment Mission to Canada slated for this year.

Part of on-going developments aimed at enhancing Canadian-Thai trade and investment relations, this latest dialogue was sponsored by the Asia Pacific Foundation of Canada in co-operation with the Industrial Finance Corporation of Thailand.

them, stresses the guide, pointing out the fact that traditional links with Western Europe are strong and competition is fierce.

As well, European competitors are receptive to licensing, industrial and technical co-operation, joint ventures and other agreement forms favored by the Yugoslav government. They also engage more readily in countertrade as a means of penetrating the Yugoslav market.

But that, the guide also stresses, should not deter determined Canadian exporters.

"Given this competition, Canadian businessmen must study these alternatives closely when approaching the Yugoslav market," says the guide. "Co-operation in third countries offers a special challenge to Canadian firms."

After recent successes, it seems there are select opportunities for Canadian and Yugoslav firms to work together, "particularly in developing countries belonging to the non-aligned movement, where Yugoslavia has good connections."

"Yugoslavia's cheaper manpower, particularly in civil engineering," the guide states, "makes the possibility of teaming up with this country attractive."

In addition to discussing trade opportunities in this country, *Yugoslavia* — A Guide for Canadian Exporters provides tips on doing business there, information on federal export assistance programs and useful contacts.

- provide the technical support needed for the development and completion of joint projects; and;
- receive private sector missions of partners involved in co-operative undertakings.

While the Agreement on Economic and Industrial Co-operation was the "most important," signatures were also appended to a Protocol to the Taxation Convention of 1975 and a Protocol to the 1956 Canada/France Agreement on the Admission of Trainees.

The signings, particularly of the Economic and Industrial Co-operation Agreement, are a follow-up to an industrial co-operation mission last November to France led by DRIE Minister Michel Coté, who also inaugurated a new consulate and trade office in Lyon, France's second most important industrial centre.
