Mr. MAYHEW: From December 1, 1941 to May 20, 1946, the ceiling prices on corn starch and on glucose were their basic period prices (i.e. maximum price established in the four-week period September 15 to October 11, 1941). On May 20, 1946, the rate of subsidy on imported corn was reduced and compensating increases of 1½ cents per pound at the manufacturers' level on both starch and glucose were authorized.
