REQUEST FOR AID TO MUNICIPALITIES RE-SPECTING UNEMPLOYMENT ASSISTANCE

On the orders of the day:

Mr. Harold E. Winch (Vancouver East): I should like to ask the Minister of Finance if he can advise the house whether any consideration is being given to the provision of financial aid to municipalities which, after May 15, wll have to assume heavily increased commitments for welfare because unemployment seasonal benefits end on that date.

Hon. Donald M. Fleming (Minister of Finance): I think the hon. member must be aware that provision has been made by parliament, at the request of the present government, for the sharing with the provinces of unemployment assistance on an equal basis, without any of the threshold provisions that limited that kind of aid under the former government. He must be aware also that very extensive provision has been made through the large grants under the Federal-Provincial Tax-Sharing Arrangements Act for the assistance of the provinces and, through them, the municipalities.

Mr. Winch: I have a supplementary question. I think the minister misunderstood me. I am completely aware of the commitments of the federal government and of the 50-50 arrangement between the federal government and provincial governments with regard to

Will the minister see that the direction is negated at once, because obviously it is at serious variance with the interests of Canadian workers.

Mr. Fleming (Eglinton): Some day, Mr. Speaker, the hon. member will ask a question not accompanied by a speech or a harangue, but he has not learned to do so yet. He asked a question a moment ago, and I answered his question.
