(a) What are the names of the persons who were present at Mr. Billett's initial hearing on June 17, 1963 (b) which of these persons gave evidence on Mr. Billett's case, and which of such persons gave evidence under oath (c) how many written statements were filed at the hearing with respect to the charge against Mr. Billett and by whom (d) which of such statements were duly sworn to (e) was Mr. Billett given the chance to cross examine any of the witnesses and, if not, for what reason?

5. (a) What are the names of the persons who were present during the investigation of Mr. Billett's case on June 20, 1963 (b) which of these persons gave evidence on Mr. Billett's case (c) which of such persons gave evidence under oath (d) was Mr. Billett given the chance to cross examine the witnesses and, if not, for what reason?

6. Did Mr. Billett file an appeal against his suspension or dismissal in June, 1963 and, if so (a) before whom was the appeal heard (b) was sworn evidence given during this appeal and by whom (c) was Mr. Billett given the opportunity of being present when his appeal was being considered and, if not, for what reason?

7. Did Mr. Billett file proper grievance papers with respect to his suspension or dismissal in June, 1963 and, if so, what detailed action was taken on his grievance?

8. Have any written adverse reports been filed on Mr. Billett's employment in the dockyard since May, 1954 and, if so (a) on what dates were such reports filed and what was the nature of such adverse reports (b) was Mr. Billett informed as to the contents of any adverse reports and, if so, on what dates; if not, for what reason?

9. (a) What was the reason for Mr. Billett being struck off strength of the dockyard in June, 1963 (b) was Mr. Billett advised in writing as to the reason for such dismissal (c) what was Mr. Billett's status as to seniority in the dockyard in June 1963?
