LIBRARY OF PARLIAMENT-MOTION FOR CONCURRENCE IN REPORT OF JOINT COMMITTEE

Hon. G. J. McIlraith (Minister of Public Works): Mr. Speaker, I move:

If a woman is required in the library to do cleaning work, why should she be paid less when parliament is not in session than when parliament is in session?
