On the orders of the day:

**Mr. André Fortin (Lotbinière):** Mr. Speaker, I wish to direct a question to the Secretary of State.

Recently I asked him if the report he had promised to table about the use and allocation of time granted by the C.B.C. to political and non political movements and others was ready and he replied that he did not know what I was talking about. Now that he does, I would like to ask him if he still intends to promise such a study of the C.B.C.'s policy in that particular field, before the representatives of the C.B.C. give evidence before the parliamentary committee on broadcasting, films and assistance to the arts, as announced?

**Hon. Gérard Pelletier (Secretary of State):** Mr. Speaker, on the contrary, I think the hon. member is pretending to know that I know, but apparently he does not know that I do not know, because I tried to find in *Hansard*—and, in that respect, I had some help—a sentence of mine that could have led him to believe that a report would be tabled in the house on that matter, and I have not found anything to that effect.

On the other hand, when the matter was raised I remember having told the hon. member that the facts that gave rise to his question were not clear, that it could not be answered until he had explained those facts, and I find that he did so during the debate on the adjournment motion but, at that time, unfortunately, I was away from the house and Canada. The C.B.C. prefers to give evidence before the committee on broadcasting, films and assistance to the arts, because it is a complex question and the C.B.C. would like to be able to explain and discuss it with hon. members who sit on the committee.

**Mr. Fortin:** Mr. Speaker, I do not know if the Secretary of State knows that you do not know that he does not know, but we get nowhere with questions like that.
