OPERATIONSQuestion No. 2,064—**Mr. Coates:**

Is the Department of Regional Economic Expansion considering the closure or any reductions in the operations of the Department at Amherst, Nova Scotia and, if so, what are its intentions in this regard and for what reasons?

Mr. Russell C. Honey (Parliamentary Secretary to Minister of Regional Economic Expansion): In accordance with agreements made with the three Maritime provinces in 1966, these provinces will next April assume the operation and maintenance of all works undertaken under the Maritime Marshland Rehabilitation Act. There will accordingly be some adjustments in the work of federal staff located at Moncton and Amherst. This is currently being reviewed in relation to the other responsibilities of the Department.
